Guidelines for Handling Suspected Food Poisoning Incidents at National Chung Hsing University

Passed by the University Health Committee of 2023 school year first semester on January 3, 2024


- I. To provide a clear protocol for handling suspected food poisoning incidents among its faculty and students, National Chung Hsing University (hereinafter referred to as "the University") has established the "Guidelines for Handling Suspected Food Poisoning Incidents at National Chung Hsing University" (hereinafter referred to as "these Guidelines") based on the *School Health Act* and the "Guidelines for Food Hygiene Management in Colleges and Universities".
- II. According to the Food and Drug Administration, food poisoning is defined as follows:
 - 1) If two or more individuals experience similar symptoms after consuming the same food, it is considered a food poisoning case.
 - 2) A single case of symptoms caused by botulinum toxin, with the toxin detected in both the individual and the suspected food, or inferred from epidemiological investigation to be caused by the consumed food, is also considered a food poisoning case. This also applies to acute poisoning from chemicals or natural toxins from food, even if only one person is affected.
 - 3) Cases inferred from epidemiological investigation to be caused by food consumption are also considered food poisoning incidents.
- III. Handling of suspected food poisoning incidents involves:
 - Report the suspected case to the Health and Counseling Center or Student Safety Counseling Office within the Office of Student Affairs. These units shall assist in quickly obtaining medical treatment for affected students, placing students without medical treatment, and inform mentors and parents or emergency contacts.
 - 2) Notification of relevant units involves:
 - 1. The Office of Student Affairs' Health and Counseling Center shall report to the jurisdictional health authority.
 - 2. The Office of Student Affairs' Student Safety Counseling Office shall report to the Ministry of Education within 2 hours upon being aware of the incident, in accordance with the "Campus Safety and Disaster Incident Reporting Guidelines."
 - 3) The Office of Student Affairs' Health and Counseling Center and the Office of General Affairs' Division of Property Operation Management shall assist the governing health authorities in investigating the causes and collecting samples related to the incident, including food samples, patient vomit, and feces, and cooperate with the health authorities on subsequent handling matters.
 - 4) The Office of General Affairs' Division of Property Operation Management may request campus food vendors involved in a food poisoning incident to cease providing food. If the health authorities determine the campus vendor is responsible, such vendor shall make compensation, implement improvements within the deadline, pay for fines, or terminate contract according to the contract terms.
 - 5) The handling results shall be reported to the President by the Office of Student Affairs. If external communication is needed, it will be handled uniformly by the Office of Secretariat.
 - 6) Follow-up actions:
 - 1. The Office of Student Affairs' Health and Counseling Center shall monitor the treatment of food poisoning cases.
 - 2. The Office of Student Affairs' Student Life Division shall assist with group insurance claims and

leave matters for students. In addition to the above procedures, suspected food poisoning incidents shall also be handled according to the "Suspected Food Poisoning Incident Handling Process" (as per attachment).

- IV. Matters not covered by these Guidelines shall be handled in accordance with relevant laws.
- V. These Guidelines shall be implemented after approval by the University Health Committee and endorsement by the President. Any amendments thereto shall be subject to the same process.

Based on Paragraph 2, Article 15 of the *School Health Act* and Article 21 of the "Regulations on Hygiene Management for School Cafeterias and Kitchen Staff Consumer Cooperatives," the following procedures are implemented:

Note: 1. Definition of Food Poisoning (Food and Drug Administration):

- (1) If two or more individuals experience similar symptoms after consuming the same food, it is considered a food poisoning case.
- (2) A single case of symptoms caused by botulinum toxin, with the toxin detected in both the individual and the suspected food, or inferred from epidemiological investigation to be caused by the consumed food, is also considered a food poisoning case. This also applies to acute poisoning from chemicals or natural toxins from food, even if only one person is affected.
- (3) Cases inferred from epidemiological investigation to be caused by food consumption are also considered food poisoning incidents.
- 2. On November 19, 2019, the Ministry of Education amended the "Guidelines for Reporting School Safety and Disaster Events," among which "food poisoning" is classified as an urgent event. Schools are required to report food poisoning incidents to the School Safety Reporting Network no later than 2 hours after being

aware of the incident.

3. The universities are required to preserve leftovers, vomit, excrement, and remaining food from the restaurant operators in the refrigerator's cold room for health authorities' inspection.
